The voice of the faith community was heard & prayers answered as together we passed the

Housing Opportunities Made Equitable (HOME Bill) and Governor Mark Dayton signed it into Law on May 1, 2014 (National Day of Prayer)

MICAH was asked, with Integrated Community Solutions, to coordinate the legislative work with the African American Leadership Forum, Build Wealth MN, and a diverse group of 30 organizations. This law will assist People of Color and American Indians with the opportunity to become homeowners through more accessible mortgage financing and enhanced financial capacity training to increase probability of successful homeownership.

MICAH NE Chapter Leadership Team

We are a group, representing diverse faith communities, living in both Ramsey and Washington counties, and meeting monthly, alternating between the city halls of Mahtomedi and White Bear Lake. We cultivate relationships with city, state and Met Council officials and administrators.

During 2014 we have urged the city of Mahtomedi to include affordable housing in the development of a former school site and supported the city's plan for a totally affordable apartment building for seniors on a former restaurant site. We continue to work with and support St. Andrew's Resource Center, Hope for the Journey Home, and Solid Ground as each helps homeless families toward permanent and affordable housing. We support and encourage the building of Habitat for Humanity homes in our communities; one is being built in White Bear Lake this year. We have representation on the Citizens Advisory Council for the Gateway Corridor and advocate for transit to make access to jobs available for the folks currently living in affordable neighborhoods as well as making future affordable housing possible. We continue to advocate at the state level through several agencies and organizations such as MICAH and JRLC.

Recently the Nicollet Ridge Apartment complex in Burnsville was sold to a Philadelphia-based real estate trust called Resource Residential, and 262 residents faced displacement when the new management began ending participation in the federal Housing Choice Voucher Program. Ninety-four of the 339 apartments at Nicollet Ridge were under this program and provided well situated decent, safe, affordable housing for people with low incomes, disabilities, the elderly and other disadvantaged groups.

Jennifer Keogh, Dakota Co. CDA's Housing Assistance Director and Rebecca Bowers, Dakota Co. Housing Resource Developer, sprang into action and called a meeting of local community partners.

MICAH represented the faith community in this collaboration that began to address this serious situation. 42 of the households faced losing their homes between the end of May and the end of June. An event with Nicollet Ridge tenants was quickly planned to bring together information,

resources, community connections and the means to determine the housing needs of these households. Southern Minnesota Regional Legal Services (SMRLS) interviewed some of the impacted residents. MICAH began to alert the faith community to the potential need for assisting these households with packing and moving of their belongings.

Living up to its prophetic name, MICAH prepared to bring this situation to the public's attention through the newspaper. With the vacancy rate currently under 2% these people would have little opportunity to remain in their community, if they could even locate another unit.

SunThisWeek Newspaper carried an article covering an interview with Mark Ulfers, executive director of Dakota Co. CDA and the situation received front page coverage by the Star Tribune, including the personal situation of several of the affected tenants.

As this situation unfolded Brian Kroker, Regional VP of Resource Residential, responded to a letter from SMRLS stating that they were unaware of the disparate impact that their business decision was having. They entered into rent negotiations with the CDA and proposed a rent structure that the CDA accepted. The impacted tenants are having to cover the increased rent themselves, but are relieved that they will be able to continue living at Nicollet Ridge. The highest rent increase was \$50.

The Nicollet Ridge renovation plan will continue and the CDA has been told that another rent increase will take place next year as the property is upgraded.

According to Jennifer Keogh, "We were able to save many families from ending in homelessness; a great success story. This would not have happened without your (MICAH's) assistance and the collaborative effort from our community partners."
