Executive Summary

Over the past 20 years, the National Coalition for the Homeless (NCH) has documented 1,852 incidents of violence against people who were homeless at the hands of people who were not homeless. At least 515 victims experiencing homelessness violently lost their lives due solely to their lack of housing.

These crimes were likely motivated by the perpetrator's bias against people experiencing homelessness and were facilitated by their ability to target homeless people with relative ease. The crimes are a litany of atrocities: murder, beatings, rapes, and mutilations. Victims have died in unfathomable ways. not only have they been shot or stabbed to death, but they have also been set on fire, drowned, or beheaded.

While NCH has documented compelling data regarding the number and severity of attacks, these acts are underreported. The Bureau of Justice Statistics found that in 2019, "less than half (44%) of violent victimizations were reported to police." Furthermore, many attacks were likely even more gruesome than available reports imply.

Since the 1980s, the homeless community--and poor people in general--have been ostracized and dehumanized. According to the National Homelessness Law Center, at least 187 cities have enacted laws to criminalize life-sustaining acts like camping, sleeping, and panhandling. Criminalizing homleessness villainizes and pushes people experiencing homelessness into hiding. The forced isolation caused by criminalization makes people experiencing homeless targets for those intent on causing harm to them. Because the homeless community is often forced to live on the outskirts of the community, many attacks go unreported, and homeless people are far more likely than the general population to be a victim of violent crime.

Anti-homeless violence lays bare the structural and economic injustice suffered by those who are insecurely housed. The severity of these attacks necessitates immediate policy changes, enhanced services, and legislative reforms.

Key Findings

Over the past 20 years, NCH has documented 1,852 reported acts of violence have been committed against homeless individuals. Reported violence has occurred in 48 states, Puerto Rico, and Washington, DC. Perpetrators of these attacks were generally male and under the age of 40.

From 2018 to 2019:

- There were 83 incidents of anti-homeless violence
- **39** victims experiencing homelessness lost their lives
- 97% of lethal attacks were perpetrated by men
- 77% of perpetrators were 40 years old or younger
- 85% of the victims who lost their lives were men
- 65% of victims who lost their lives were older than 40

This report is intended to educate lawmakers, advocates, and the general public about hate crimes and violence committed against the homeless community. Our goal is to bring about change and ensure the protection of civil rights for everyone, regardless of economic circumstances or housing status.

As part of its mission, the National Coalition for the Homeless is committed to creating the systemic and attitudinal changes necessary to end homelessness. In order to build health and compassionate communities, the civil and human rights of poor people and people experiencing homelessness must be protected and enforced.

Elected officials, advocates, and the members of the public at large all have a role to play in combating bias and violence against people who experience homelessness.

> A hate crime is defined by the U.S. Department of Justice's Federal Bureau of Investigation (FBI) as a "criminal offense committed against a person, property, or society that is motivated, in whole or in part, by the offender's bias."

Background

Homelessness is not accidental, nor is it inevitable. We as society chose not to ensure that all residents have access to housing. In general, people do not choose to be homeless. Instead, we as a society are making it impossible for all people to earn a living wage and to be able to afford adequate housing, health care, and other basic needs. Specific policies have created an epidemic of income inequality, racial injustice, and homelessness.

In its 2019 annual Point-in-Time Count, the U.S. Department of Housing and Urban Development (HUD) estimated that on any given night there were 568,000, men, women, and children were homeless.¹ Another 500,000 or so formerly homeless individuals and families reside in supportive housing through HUD's homeless programs.

According to HUD's counts, roughly 210,160 are unsheltered on any given night. The National Homelessness Law Center, releases an annual report called, Housing Not Handcuffs, in which they analyze the ordinances in 187 communities across the country that criminalize daily acts of survival for people who are forced to live outdoors.² These laws push a cycle of structural violence3--or social injustice--that leads to negative perceptions of people who are homeless--perceptions that further relay a general lack of compassion and motivation to invest in housing and other systemic solutions to endemic poverty.

Life expectancy for someone who is homeless can be 20-30 years younger than the general population

This dehumanization of our brothers and sisters who are experiencing homelessness leads to an environment in which hate crimes against these individuals are far too common and far too deadly. As Winter and Leighton (1999)state, "Structural violence is problematic in and of itself... but it is also dangerous because it frequently leads to direct violence."4

In this report, we analyze the direct violence people experiencing homelessness face from the housed community. The report includes descriptions of reported occurrences of biasmotivated violence and solutions for advocates, makers and community members to policy help mitigate violence against our most vulnerable.

Methodology

The data presented in this report on violent acts committed against the homeless population were gathered from a variety of sources. NCH staff collected stories from published national and local news reports, and homeless advocates and local service providers across the country provided information about incidents in their communities.

We also examined community death reports for missing information. Lastly, and most importantly, this report relied on the voices of homeless individuals and formerly homeless people who selfreported incidents they have experienced.


Every reported incident was subjected to a rigorous fact-checking process designed to evaluate and verify accuracy. This process entailed followup discussions with those closely involved with the incident. These accounts were corroborated by other news sources reporting each incident.

While the motive for each attack was not always clear from the information available, in many cases, there was confirmation that these violent acts were perpetrated because of a bias against the victim's Other acts deemed housing status. were opportunistic and committed merely because the victim, due to their lack of housing, was in a vulnerable position. Only attacks perpetrated by

housed individuals against un-housed individuals were evaluated. Crimes committed by persons experiencing homelessness against another homeless person were excluded from this report.

While NCH has made every effort to verify the facts regarding each case included in this report, new information about incidents may become available after its publication. As additional evidence emerges, about prior, new, or previously unknown cases, NCH may revise our findings.


This report lays out our findings from 2018 and 2019, followed by a brief discussion and policy solutions. Appendix A and Appendix B include the perspective of legal scholars on how to combat hate crimes, and Appendix C offers guidance for communities on hate crimes legislation. Findings


Demographics of Victims and Perpetrators

Victims of homeless hate crimes are most commonly middle-aged men. In 2018-2019, 81.8% of victims were between the ages of 21-60. 79.8% of the victims were men, while 20.2% were women. Perpetrators of hate crimes against homeless individuals are primarily younger men. In 2018 and 2019, 95% of the perpetrators were male, while the women represented only 4%. 77.3% of the perpetrators were 40 years old and younger.



Geography

The 83 attacks committed were against individuals experiencing homelessness in 2018 and 2019 across 30 states including the District of Columbia. An astonishing 22.9% of attacks reported in 2018-2019 took place in California. For the last four years, California has surpassed Florida with the most attacks. These two states have consistently seen high rates of violence against people experiencing homelessness, with over 600 attacks in these two states alone over the past 20 years.



Summary of Lethal Cases in 2018 and 2019

In the 83 documented incidents of anti-homeless violence between 2018 and 2019, 39 people experiencing homelessness lost their lives in violent attacks. Below is a sample of some of the most horrific lethal attacks. A full summary of reported cases can be found in Appendix D.

March 18th, 2018: Albuquerque, New Mexico⁵

Police Say Pair of Teens Killed Homeless Man for Sport

Two teens left a birthday party to kill a homeless man for sport, then later returned to the party after killing Ronnie Ross. Timothy Chavez, 15 years old, and Anthony Gallegos, 17-years-old, left a friend's birthday party to shoot a homeless man six times. They bragged to people that they had shot a "hobo" in the back.

April 15, 2018: San Francisco, California⁶

Brutal Chinatown killing connected to SF man suspected of kicking homeless


Quang Truong, 49, was found dead inside a large cardboard box which he called home, covered in blood from a massive head wound. Samuel Youmtoub, 59, a computer technician who has been known to be frustrated with the homeless population in San Francisco.

July 7, 2018: Nashville, Tennessee⁷

Homeless man shot and killed in North Nashville

Frazier Lumpkins, a 66-year-old homeless man, was shot and killed in North Nashville. An individual in the neighborhood said, "He was sweet and kind... it's just heartbreaking to know they shot him down like that."

November 6, 2018: Los Angeles⁸

California homeless man repeatedly stabbed in shocking video; \$50G reward offered

Los Angeles police released a video on November 6th showing a man approaching a homeless man Hernando Perez, 58, who was sleeping on a bench and repeatedly stabbed him. The man was wearing a light gray hooded sweatshirt. The perp has been desired as a man between 25-35 years old and about 6 feet 3 inches tall with a thin build and brown hair.

November 28, 2018: Phoenix, Arizona⁹

Phoenix man kills homeless person because he's upset about homeless population

A man was arrested after police said he murdered a homeless man because he was angry about the increase in the homeless population around his north Phoenix neighborhood.

July 3, 2019: Traverse City, Michigan¹⁰

Young Michigan man arrested In May death of homeless camper

James Chisholm, 62-year-old homeless man whose body was found by hikers with his throat slashed. Police say 18-year-old Joshua Vandehoef turned himself in for the crime.

August 16th, 2019: Westminster, Maryland¹¹

Fourth suspect sought after arrests in beating death of Westminster homeless man

Officials found the body of Duc Le, a 45-year-old homeless man who was known to sleep in the area. Le was assaulted by four men who then dumped his body. Three of the suspects have been arrested: Andrew Holguin, 21, Christian Huerta, 19, and a 16year-old unidentified juvenile. A fourth man, Jeffrey Andrade, 18, is still on the run.



Summary of Non-Lethal Cases in 2018 and 2019

In 2018 and 2019, 45 out of the 83 total cases were not lethal, but victims were nevertheless deeply scarred. The non-lethal attacks reported here highlight endemic discrimination and the dehumanization people experiencing homelessness. A full list of reported non-lethal cases can be found in Appendix E.

Abduction

July 30th, 2018: Montgomery, Alabama¹²

Homeless man kidnapped, forced to withdraw money from downtown Montgomery ATM

Amani Tucker, 32 and Keontaye Giles, 31 were charred with first-degree kidnapping. The victim told police that he was forced into a vehicle against his will and was forced to withdraw money from his bank account.

December 18th, 2019: Miami, Florida¹³

Surveillance video shows homeless man in chains before being beaten, abducted

Kennith Dougals, 36, and Terraill Jenkins, 38, have been arrested for abducted a 43-year-old homeless man. In a video that was released you can see the homeless man being held hostage with a chain around his neck. The perpetrators then punch him in the head and knock him to the ground.

Assault with a Deadly Weapon

October 5th, 2018: Los Angeles, California¹⁴

Police seek suspect in 'evil' acid attack on homeless people

Police are searching for whoever attacked a homeless man and woman while sleeping by throwing acid on them. The man awoke to a female companion screaming in pain and running from where they were sleeping. The man saw burn marks on her face and arms, then realized his face also was burning but to a lesser degree.

September 25, 2019: Los Angeles, California¹⁵

California man allegedly tried to set homeless man on fire: report

A 32-year-old male is accused of lighting a sleeping homeless person on fire then taking photos of the blaze. The suspect was charged with attempted murder.

Police Brutality

February 18th, 2018: Nome, Alaska¹⁶

Officer admitted punching a homeless woman while on duty, only to be hired back by the Nome Police Department

Community service officer Carl Putnam had been working in the community for five years when he picked up a homeless woman and attempted to drive her to the emergency shelter. The woman, who had been intoxicated, passed out on the way to the shelter. Putnam became frustrated and punched her in the head. In August 2018, the Nome police department hired the officer back as a 911 dispatcher making \$21.52 an hour.

August 14, 2019: Los Angeles, California¹⁷

LAPD Shoots Unarmed Homeless Man over Noise Complaint from Neighbor

While responding to a noise complaint, officers from the Los Angeles Police Department confronted John Penny, a homeless man who had permission from the property owner to live in the driveway. Police said Penny was armed with a "bottle" when they first confronted him. Police stated, "Penny refused to drop the bottle and approached officers. The officers deployed a taser. However, it appears the darts did not strike Penny. Penny then armed himself with a three-foot-long wooden plank and again to approach the officers, which resulted in an Officer-Involved-Shooting."



Sexual Assault

June 20, 2018: Fayetteville, North Carolina¹⁸ Fayetteville homeless shelter staffer charged with fondling resident

Theon Trammell, 26, a former shelter worker at New Life Mission, was arrested with a misdemeanor sexual battery charge after fondling an 18-year-old resident of the homeless shelter.

August 21, 2018: Cocoa Beach, Florida¹⁹

Officials: Man had sex with teenage daughter of homeless woman whom he befriended

A 45-year-old man had sex with the 13-year-old daughter of a homeless woman whom he befriended while she was panhandling. This man would book motel rooms for the woman and her family.

Beating

February 12, 2018: New York, New York²⁰

Group beats up homeless man inside Columbus Circle subway station, police say

28-year-old homeless man was on the northbound A train platform inside the station when between twenty and thirty teens and young adults attacked him. The man was taken to the hospital with a cut to his head, swelling and bruising in both of his eyes, and a broken tooth. Two16 -year-olds were charged with gang assault and obstruction.

September 26, 2019: Portland, Oregon²¹ "Incredulous" 911 caller says brutal attack on homeless man was dismissed

Four teenage boys attacked a homeless man in downtown Portland. A passer-by called in the incident and started following the teenage boys. However, the dispatcher said there will be no formal report unless the man who was attacked called the police.

Harassment

October 2, 2018: Syracuse, New York²²

Dunkin' employees fired after viral video shows worker dumping water on homeless man

Dunkin' has fired employees involved in a viral video that shows one worker in a New York store dumping a pitcher of water on a homeless man, while another person is laughing. The victim is named Jeremy Dufresne. One employee said something about Dufresne sleeping, then dumped water on him. The employee said, "How many times I've got to tell you to stop sleeping in here...you're here all day." Dufresne suffered from schizophrenia and was inside the Dunkin' to charge his phone so that he could call his mother and say goodnight.

August 1, 2019: Portland, Oregon²³

Portland man walks into homeless camp, intentionally starts fire that torches tent

44-year-old man was arrested after he told homeless campers to move from their location or risk their positions being set on fire. Roy Elworthy later returned and set one of the homeless men's items on fire.

Media Exploitation

August 7th, 2018: Las Vegas, Nevada²⁴

Khabib Nurmagomedov posts video of himself paying homeless people to do push-ups

UFC lightweight champion Khabib Nurmagomedov and his cousin posted videos of them paying homeless people if they could do a pushup. The post was later taken down.

May 17th, 2019: Redding, California²⁵

Redding police search for young man filmed kicking homeless person

The Redding Police Department posted a cell phone video of a juvenile kicking a homeless person lying on the ground. Due to the age of the perpetrator, the video was later removed.

MULTI MEDIA EXPLOITATION: AN EXPLANATION

Multimedia exploitation of the homeless population is a severe growing problem, just as digital bullying is becoming more common among the entire population.

In the early 2000's, NCH mounted a campaign against a group of videos that were released under the name, "Bum Fights." These videos included homeless men beating each other up and performing dangerous stunts like banging their heads through glass windows and going down stairs in a shopping cart. The un-housed people who participated were compensated with a few dollars or a six pack of beer, and suffered severe injuries as a result of the videos. These videos degrade and stigmatize homeless persons by perpetuating the stereotype that people living in a state of homelessness are "bums" and that they have no other worth than to provide entertainment to the rest of society by causing themselves or others bodily harm. "Bum Fights," has now been viewed more than 7.7 million times, garnering about 6,490 likes by YouTube users.

It is the decision of the National Coalition for the Homeless to include multimedia exploitation in a report on hate crimes and violence against the homeless, as there have been documented cases that show the immediate correlation between watching videos that display violence toward homeless individuals, and committing "copycat" crimes against that population. These videos are foul, hateful, and unbecoming of a modern progressive society.

Discussion

The level of gruesome violence--both lethal and non-lethal--described in this report speaks to the urgent need to act. Some of the violent incidents we document here are grounded in perpetrators that people experiencing being angry homelessness are in their neighborhood or in their city. Other hate crimes seem to have been perpetrated because the attacker found an easy target and may have believed they would not be caught. Still others were perpetrated "for sport," and the perpetrators bragged about their crimes to friends. The fact that such horrendous crimes continue to occur against people experiencing homelessness suggests that in the minds of some people, those who are homeless are somehow less than human. Additionally, the fact that many of the crimes we document in this report did not result in arrest or conviction shore up the notion that people can sometimes "get away with it" if they attack, rape, or kill a homeless person.

Our society's unwillingness to commit adequate resources to ensure housing and services for all people has created an us and them dynamic, in which some in the general public do not believe that others are deserving of housing--or even a basic level of safety and stability. This isolation, segregation, and public perception of homeless people being a "class apart" leads to fear of the homeless population among many in the general public. The lack of education and understanding of how people became homeless helps create an "otherness," which leads to fear and disgust when many housed individuals come across a person experiencing homelessness.

Examples of municipal codes that criminalize life sustaining behavior include:


- Prohibiting sleeping in public city-wide, or in a particular public place
- Prohibiting camping in public city-wide, or in a particular public space
- Prohibiting sitting/lying in a particular public space
- Prohibiting lodging, living, or sleeping in vehicles (or parking a vehicle used as a lodging/living accommodation)
- Prohibiting loitering/loafing/vagrancy city-wide
- Prohibiting loitering/loafing in particular public places
- Laws that prohibit panhandling in public places
- Limiting, banning or requiring onerous permitting for food sharing city-wide or in particular public places

As a society, we have isolated and segregated people who experience homelessness, leading to a culture of fear and disgust when encountering a person who is homeless. Culturally, we have branded the population of people who are unhoused as criminals, and in turn, denied them access to life sustaining activities such as a place to sleep, eat, and relieve themselves. In other words, we have dehumanized our most vulnerable to such an extent that many view them not as fellow human beings, but instead as easy targets.

CRIMINALIZING THE HOMELESS COMMUNITY

There is a documented relationship between the appearance of criminalization of homelessness laws, and the increase of hate crimes or violent acts against homeless people. In order to prove this, Florida and California will be used as case studies. Historically, many cities in these two states have enacted severe anti-camping, antipanhandling, and anti-food sharing laws, as well as other regulations that criminalize activities related with homelessness. The legislative scenario constitutes one of the factors that explains why these two states hold the highest amounts of bias-motivated crimes against homeless individuals, far surpassing their closest competitors.

One possible explanation for this is the message that criminalizing homelessness sends to the general public: "Homeless people do not matter and are not worthy of living in our city." This message is blatant in the attitudes many cities have toward homeless people and can be used as an internal justification for attacking someone.



Policy Solutions

Over the past 20 years, the National Coalition for the Homeless has documented over **1,869** hate crimes committed against homeless people by housed individuals. These attacks have cost **515** un-housed people their lives. The following policy recommendations offer short- and long-term solutions that will reduce violent crime against people experiencing homelessness and develop permanent solutions that keep all people safe and housed.

1. Ensure Housing as a Human Right for All People

The core solution to homelessness is housing. Safe, decent, affordable, and accessible housing for all not only provides a place of stability for people as they seek to reconnect with family and friends, health and community, jobs and meaning. It also keeps people from dying on the streets--from all causes, including violence crime. We as a nation must embrace housing as a basic human right, one that everyone deserves, regardless of their race, gender identity, sexual orientation, age, abilities, or any other factor.

2. Reverse ordinances and municipal practices that criminalize homelessness

Communities across the U.S. have passed anti-homeless ordinances that create an environment of harassment, while failing to offer solutions. Laws that outlaw camping, sleeping, eating, bathing, and relieving oneself in public--as well as anti-panhandling ordinances essentially make it illegal for someone to be homeless, opening the door to mistreatment by law enforcement and the general public. A first important step is for communities to reverse these laws and practices and instead focus on housing, supportive services, and other real solutions that help people get off the street.

3. Enact Hate Crimes Legislation and Sentencing Guidelines

Due to the bias-motivated violence documented here, and in past Hate Crimes reports, NCH advocates for both including people experiencing homelessness as a protected class under hate crimes status, and implementing vulnerable victims sentencing guidelines. Either type of initiatives would serve to discourage this particular type of biased victimization, and work to find justice for homeless victims. 4. Collect More Complete Data on Crimes against People Experiencing Homelessness

NCH advocates for federal, state and city governments to conduct data collections to track violence against homeless individuals. Arrest reports could include a box indicating if a victim was homeless, or HUD could add a victimization survey to its annual Point-in-Time count and service intake survey.

Conclusion

While some communities are taking positive steps towards protecting homeless individuals, violence against people who are homeless is a trend that will continue to grow unless there is true accountability for crimes committed, established methods of prevention, and positive action taken by advocates, legislators, and community members. Policy alone will not change the institutionalized fear and disgust for people experiencing homelessness that our communities have cultivated over the last 40 years. Legal protections must also be accompanied by a cultural shift.

Cultural shift begins with daily interaction between housed and un-housed community members. We must begin to acknowledge our un-housed neighbors, and affirm our shared humanity. Try to smile and say hello as you pass someone you believe to be homeless. Ask the person their name and share yours. Recognizing the humanity in someone who may have been invisible for an extended period of time can have huge ramifications on their health and well-being.

With this combination of humanity and just policy change, we can end the direct violence our homeless community faces on a daily basis and begin to correct the structural violence that created and perpetuates homelessness.



Hate Crime Status vs. Vulnerable Victims Status

Introduction: Hate Crime

Beginning in the late 1970s major metropolitan areas and various states began to address hate violence not only through new criminal laws but also through the formation of data collection, specialized police units, and new policies starting with Massachusetts.

In recent years, a debate has intensified about whether the criminal law should include targeted violence against the homeless in state and federal hate crime statutes and data collection efforts. Currently, almost half a dozen states include homeless status in their hate crime laws, although attempts at the federal level and in other states have stalled (Stoops, 2014). Hate crimes are discriminatory criminal acts committed because of an individual's actual or perceived membership in a particular socially identifiable status group. Status characteristics are those material attributes, like race or sexual orientation, common to a socially identifiable class of people. While hate crime laws and other modern legal protections on the basis of status are relatively recent enactments, their roots extend to the post–civil war era constitutional amendments.

Federal Law

The federal government does not protect the homeless in hate crime law (18 U.S.C. 249) or enumerate anti-homeless bias incidents in its related annual hate crime data collection, it does have a definition of homelessness and a numerical estimate of people affected by it. In its 2014 Annual Homeless Assessment Report to Congress, the Department of Housing and Urban Development estimates that there are 578,424 homeless individuals nightly, with 31% of those or 177,373 being unsheltered, compared with 69% residing in shelters (Henry, Cortes, Shivji, & Buck, 2014). The U.S. population is 319 million (U.S. Census Bureau, 2015).

Federal law has defined homelessness in part as those without a "fixed, regular and adequate nighttime residence" that may include shelters and hotels as well as vehicles or public places not designed for housing,

such as campsites, parks, or transportation facilities (The McKinney-Vento Homeless Assistance Act, 2009).

The overall rate of criminal victimization for these homeless Americans is staggering, far exceeding that of other groups. A series of state and local studies and surveys cited in Senate testimony showed annual criminal victimization rates for the homeless between 34% and 81.9% ("Crimes Against America's Homeless," 2010). In contrast, in 2013 the National Crime Victimization Survey showed the overall housed population 12 years and older faced an annual rate of victimization of 1.2% for violent crime and 0.4% for serious violent crimes (Truman & Langton, 2014).

Vulnerable Victim and Hate Crime Approaches

While there is little debate about the fact that the homeless face targeted violence, there are vastly differing views about how to address the problem. The NCH and other homeless advocates in the past promoted the inclusion of the homeless as a protected and enumerated category in hate crime laws and data collection initiatives, while others believe such efforts are misplaced. Prejudice and stereotypes against the homeless, and the apparent role these biases play in many violent attacks, are a strong foundational argument for their inclusion in hate crime laws, supporters contend.

Oppression and prejudice against them as a socially identifiable class Identical offenders such as bigoted skinheads, neighborhood defenders protecting their turf, as well as young male thrill offenders who share identifiable characteristics and motivations Identical methods of attack that revolve around personal or imprecise weapons that cause substantial suffering frequently hostile or ineffective legal response to protect them. Steiner (2009), observes,

Thus assuming homelessness were included as a prohibited bias motivation, the prosecutor would be required to show that the victimization occurred not merely because the victim was homeless, but rather because of a pre-existing negative attitude toward homelessness, a high standard to be sure. (p. 38)

In contrast, federal vulnerable victim sentencing law's broad range arguably could already cover homelessness:

"Vulnerable victim" means a person (A) who is a victim of the offense of conviction . . . and (B) who is unusually vulnerable due to age, physical or mental condition, or who is otherwise particularly susceptible to the criminal conduct. (U.S.S.G. § 3A1.1, comment, [n.2])

Still, the most legally unambiguous wording would be a specific statutory enumeration of homelessness as a protected status in vulnerable victim law. Such inclusion only requires a showing that the victim was homeless when targeted, without the necessity of delving into motive at all. Alaska is the only state to address the issue in this way:

5) the defendant knew or reasonably should have known that the victim of the offense was particularly vulnerable or incapable of resistance due to advanced age, disability, ill health, homelessness, or extreme youth or was for any other reason substantially incapable of exercising normal physical or mental powers of resistance . . . (Alaska Stat. § 12.55.155)

Enacting Effective Hate Crime Legislation in Your Community

I. Goals to Achieve

Hate crime legislation serves many purposes. Primarily, it seeks to punish and deter individuals from committing bias-motivated crimes. In naming a vulnerable group, hate crime legislation makes a statement to the community that this group has the full protection of the law and is deserving of such protection. Such legislation also ensures the recognition of fundamental human rights.

While there is a clear need to include and protect homeless individuals in hate crime legislation, cities and states across the country differ in their approaches towards accomplishing this goal. NCH believes certain concepts are essential comprehensive and effective hate crimes legislation. This guide will begin by out-lining those concepts. It continues by explaining and analyzing enacted legislation in order to understand their strengths and weaknesses. It also evaluates unsuccessful attempts to amend hate crimes legislation and possible reasons for those failures. Finally, this guide will pose arguments raised in opposition to the inclusion of homeless status in hate crimes legislation, as well as possible counter-arguments. In understanding these models, other jurisdictions can

create their own comprehensive hate crimes legislation to ensure maximum protection for individuals experiencing homelessness.

II. Recommendations for Hate Crimes Legislation

NCH recognizes that different localities are governed by different laws and have varying needs. For this reason, it is important for state and local communities to determine what protections are already in place and what their goals are for proposing hate crimes legislation to protect the homeless. NCH also believes, however, that the homeless population is due certain fundamental protections and has identified concepts that are key to comprehensive hate crimes legislation at any level. These concepts include:

- Recognition of the homeless on a person of "homeless status" as a protected class, thus, targeting a person due to their homeless status or perceived homeless status would qualify as violation of the law.
- Use of a definition of homelessness in line with 42 USC 11302 (2012) as revised by the HEARTH Act.
- 3. Inclusion of both committed hate crimes and attempts or conspiracies to commit a hate crime against a person or their property.

- Criminal and civil sanctions (including injunctions, reasonable actual or nominal damages for economic or non-economic loss, punitive damages, or attorney's fees) for violations of hate crime laws.
- 5. Development of procedures that facilitate the data collection by law enforcement and local organizations and the distribution of the data to governing bodies while maintaining the privacy of the victims. This data should be used to create strong, supported recommendations to present to lawmakers.
- 6. Requirement of law enforcement to complete trainings on how to interact effectively and respectfully with homeless populations.
- 7. Coordination between law enforcement and local service providers to ensure homeless individuals receive necessary services.
- 8. Awareness campaigns amongst high school students and other young people about homelessness

Community Policy and Education Recommendations

NCH Advocates for the following:

 "Homeless status" to be included in the federal hate crimes statistics statute. Doing so would require the Federal Bureau of Investigation to collect data on hate-motivated violence targeted against individuals who are homeless.
 H.R. 1136 was introduced in the 113th
 Congress by U.S. Representative Eddie Bernice Johnson, and was identical to three bills introduced to previous sessions of Congress.

- 2. States with hate crime statutes to include "homeless status" within their current hate crimes frame-work.
- The U.S. Department of Justice to issue a public statement acknowledging the hate crimes and/ or violence against people experiencing homelessness are a serious national problem.
- 4. The U.S. Department of Justice to issue guidelines for law enforcement agencies on how to investigate and prosecute biasmotivated crimes against people experiencing homelessness.
- Law enforcement agencies provide awareness training to trainees and officers about the causes and solutions to homelessness and how to deal effectively and respectfully with people experiencing homelessness in their communities.
- 6. Advocates and homeless service providers to provide opportunities for people who have experienced homelessness and survived biasmotivated violence to tell their stories. The Faces of Homelessness Speakers' Bureaus (composed of homeless and formerly homeless people), which visit both public and private schools in communities for the purposes of information and education, would be one method of providing opportunities for survivors to share their stories.
- 7. Federal, state, and local government to assure adequate affordable housing and services to bring an end to homelessness in our communities, and thus create safe alternatives to living in homeless situations

MODEL LANGUAGE FOR ALL LEGISLATION AND RESOLUTIONS

The following is proposed language to be used in whole or in part by local advocates to propose their own forms of homeless hate crime legislation. Local advocates are encouraged to use the whole body or the pieces of the model they deem most necessary. The model language was prepared by the National Coalition for the Homeless (NCH) and the National Law Center on Homelessness and Poverty (NLCHP). Advocates who have questions are encouraged to contact the National Coalition for the Homeless at info@nationalhomeless.org.

Whereas, hate crimes and violence against homeless persons has become a nationwide trend, 1,437 reported cases of violence against homeless people over the past 15 years (1999-2013), resulting in 375 deaths;

Whereas, the scope of prohibitions against the commission of hate crimes against certain groups of persons should include homeless persons;

Whereas, understanding violent crimes committed against homeless persons and adequate punishment for such crimes play key roles in preventing and managing violence against homeless persons; and

Whereas, law enforcement needs proper training to handle and prevent violent crimes against homeless persons;

Be it enacted:

- (1) For the purposes of this legislation, a "homeless person" means an individual or member of a family as defined in 42 .S.C. § 11302 (2009) and any regulations promulgated thereafter.
- (2) The state hate crimes statute shall be expanded to include homeless persons as a protected class.
- (3) Prohibition on Hate Crimes against Homeless Persons The following acts shall be deemed a hate crime and prohibited when carried out against a person on the basis that person's status as a homeless person:
 - (A) Assault, aggravated assault, battery, or aggravated battery upon the person; or
 - (B) Acts that deface, damage, or destroy or attempt to deface, damage, or destroy the personal property of the person; or
 - (C) Acts that result in the death of the person; or
 - (D) Any other crime against the person.

- (4) Punishments for Hate Crimes against Homeless Persons
 - (A) A person convicted of aggravated assault or aggravated battery upon a homeless person based on the victim's status as a homeless person shall be sentenced to a minimum term of 3 years and fined not more than \$10,000. The person shall be ordered by the sentencing judge to make any restitution to the victim of the offense and to perform 500 hours of community service work. Restitution and community service work shall be in addition to any fine or sentence that may be imposed and shall not be in lieu thereof.
 - (B) Whenever a person is charged with committing an assault or aggravated assault or a battery or aggravated battery upon a homeless person based on the victim's status as a homeless person, the offense for which the person is charged shall be reclassified as ollows:
 - (1) In the case of aggravated battery, from a felony of the second degree to a felony of the first degree.
 - (2) In the case of aggravated assault, from a felony of the third degree to a felony of the second degree.
 - (3) In the case of battery, from a misdemeanor of the first degree to a felony of the third degree.
 - (4) In the case of assault, from a misdemeanor of the second degree to a misdemeanor of the first de ree.
- (5) State Office of the Attorney General Study -
 - (A) The Office of the Attorney General shall assess the extent of the problem of crimes against homeless persons and develop a plan to prevent these crimes and apprehend and prosecute the perpetrators of these crimes.
 - (B) In developing the assessment and plan, the Office of the Attorney General shall consult homeless persons, service providers and advocates for homeless persons and law enforcement agencies with experience investigating crimes against homeless persons.
- (6) Law Enforcement Training on Hate Crimes against Homeless Persons –
 - (A) The lead state law enforcement agency shall develop a telecourse that shall be made available to all law enforcement agencies in the state. Every state, local, and correctional law enforcement agency shall certify that each of its officers has taken the course. The telecourse shall address crimes against homeless persons and methods of dealing effectively and humanely with homeless per-

sons. The course shall include instruction on each of the following topics:

- (1) Information about homelessness, including causes of homelessness, its impact, and solutions to homelessness.
- (2) Indicators of hate crimes.
- (3) The impact of these crimes on the victim, the victim's family, and the community.
- (4) The assistance and compensation available to victims.
- (5) The laws dealing with hate crimes and the legal rights of, and the remedies available to, victims of hate crimes.
- (6) Law enforcement procedures, reporting, and documentation of hate crimes.
- (7) Techniques and methods to handle incidents of hate crimes.
- (8) The special problems inherent in hates crimes against homeless persons and techniques on how to deal with these special problems.
- (B) The lead state law enforcement agency shall develop a protocol that law enforcement personnel are required to follow, including, but not limited, to the following:
 - (1) Preventing likely hate crimes by, among other things, establishing contact with persons and communities that are likely targets, and forming and cooperating with community hate crime prevention and response networks.
 - (2) Responding to reports of hate crimes, including reports of hate crimes committed under color of legal authority.
 - (3) Providing victim assistance and follow up, including community follow up.
 - (4) Reporting methods and procedures to track hate crimes against homeless persons.
- (C) In developing the telecourse, the lead state law enforcement agency shall consult subject matter experts including, but not limited to, the following:
 - (1) Homeless and formerly homeless individuals;
 - (2) The National Coalition for the Homeless
 - (3) Other local homeless service providers and advocates for homeless people;
 - (4) Experts on the disabilities homeless persons commonly experience; and
 - (5) Law enforcement agencies with experience in investigating hate crimes against homeless people.


